<a href="#">Textual Information(1)</a>	<p>The total number of outstanding Employee Stock Options (ESOP) granted for quarter ended September 30, 2025 was 14,80,411 options. During the quarter ended December 31, 2025, the Nomination and Remuneration Committee (NRC) of the Company in its meeting held on November 12, 2025, approved the cancellation of 11,500 Options, earlier granted on 07th June 2025 under Agro Tech Foods Limited Employees Stock Option Plan, 2024. Hence, for the quarter ended December 31, 2025, the total number of outstanding ESOP granted is 14,68,911 options. During the quarter ended December 31, 2025, the Promoter had acquired new 18,81,073 equity shares and their aggregate total shareholding enhance to 1,46,66,522 equity shares as shown in this Shareholding Pattern for quarter ended December 31, 2025. Subsequent to the acquisition, the Promoter had encumbered these 1,46,66,522 equity shares by way of "Non-Disposal Undertaking", which is also shown in this current Shareholding Pattern. Furthermore, the lock-in period for the 1,33,27,589 equity shares as shown in the Shareholding Pattern for September 30, 2025 has expired on September 30, 2025. Hence, during the quarter ended December 31, 2025, we have not shown these 1,33,27,589 equity shares under Locked in shares.</p>
<a href="#">Textual Information(2)</a>	<p>In the Shareholding Pattern ("SHP") for quarter ended March 31, 2025, in the Promoter &amp; Promoter Group, the total number of shareholders was given 2 viz (i) CAG-Tech (Mauritius) Ltd. holding 12785363 shares as Promoter and (ii) Zest Investments Ltd. holding 86 shares, as promoter group. Later, during the quarter ended June 30, 2025, Zest Investments Ltd. had transferred its 86 shares to CAG-Tech (Mauritius) Ltd., which was an inter-se transfer between the promoters/promoter group. Hence, the total shareholding of promoter/promoter group remained 12785449 shares as at June 30, 2025, while the number of shareholders had changed from 2 to 1. In the SHP for quarter ended June 30, 2025, the number of shareholders in Promoters category was shown as 1 i.e. CAG-Tech (Mauritius) Ltd. holding 12785449 shares and in the detailed shareholding pattern, we had also shown Zest Investment Ltd. with Nil shareholding, in compliance with FAQs of the Stock Exchange. Hence, in the Shareholding Pattern for previous quarter and current quarter, the number of shareholders in Promoters category is shown as 1 i.e. CAG-Tech (Mauritius) Ltd. holding 12785449 shares for quarter ended September 30, 2025 and 1,46,66,522 shares for quarter ended December 31, 2025 and in the detailed shareholding pattern, we have shown Zest Investment Ltd. with Nil shareholding. The Significant Beneficial Owners (SBO's) mentioned in the SHP for Quarter ended December 31, 2025, are the Senior Management Officials of the Registered Owner i.e. CAG- Tech (Mauritius) Limited. Since the Registered Owner holds 38.91% shareholding in the Company; the same percentage holding is attributed to each SBO, who collectively account for the 38.91% shareholding of the Company.</p>
